**BUSINESS.**

**1. Matters for discussion**

**i) Car Park re-marking at Eversley Park Centre**

Chairman reported that Mrs Marchant had been to see Aldi Site Manager about marking our car park when they do theirs, but this is not their responsibility. Sissons are doing this work. Site Manager had given Mrs Marchant a contact name of Tim Howe and she has contacted him and awaiting a reply. **Proposed we await response from Sissons before doing anything further**

**ii) Update on health & Safety Checks.**

Chairman reports that only Rugby Club to do now, everywhere else has been checked. All PAT testing for all areas has been done and certificates issued from the Compan.

**iii) Letter from White Rose about Biodigester.**

Cheque forward for payment for this annual check for £426 was signed by the Committee , as they had negotiated special price which was time important. Letter states that White Rose will pay for the emptying of this digester as they are the ones who fill this. **This was noted.**

**iv) Garden by Library**

Councillor Mrs Brown asked if the small triangular area between the paths could be flagged as people are walking over any plants which are planted. **Proposed that Councillor Brown approach Steven Booth (who did this work originally) and get a price for this work. **v) Complaint about closing of Fairway Area**

Complaint received from resident about this area not closing until 9.30pm in the evening. **Proposed Clerk write and say this is closed by volunteers and we cannot tie them down to times to do this. If resident would like to volunteer we will arrange to give him a key.**

**EXTRA ITEMS.**

**i) Finkle Hill Tennis**

Mr Varley reports he has finished doing "skirt" around this building. Has also had to put a board over part of the wall as a ball been kicked through it. **Proposed Clerk chase SDC to find out about our request for 106 money to erect a new pavillion for Tennis.**

**ii) Finkle Hill Bowls.**

Mr Varley reports that while he was working at this site the Bowls approached him asking when their shed roof will be repaired. **Chairman reports that they have been told this is not our building (just a lean to roof) and they must get this work done themselves.**

**iii) Footpath No. 12**

Councillor Mrs Prescott reports that this path is in a terrible state rubbish and overgrown. **Clerk to contact SDC and also probation to see if we can get this cleared.**
